Regional Logos (Primary)

There are three parts to the logo: the cross, the words "Blue Cross," and the region's name all in capitals. In all our communications, we should prioritize the horizontal configuration of the logo (opposite). The regional logo for Ontario is also available. In case of limited space, vertical configurations are available.

The colours allowed for the logo are blue, white (reverse), and black. Black is only used when colour printing is not possible.

For some of our business lines, there are different versions of the logo. Please contact the Marketing team to use the correct logo.



If space is limited, this symbol can be used, but the brand name must appear (e.g., social media profile image, favicon, etc.). It is recommended to incorporate as much of the "®" trademark symbol as possible.



For maximum impact, the logo should maintain consistency in shape, colours, and visibility. The following are some examples of logo applications in various contexts.




Trademark Ownership & Monitoring

The Association owns several trademarks including the words BLUE CROSS and the Blue Cross Symbol ([see Schedule B - Trademark/Brand Usage Report](#)). As well, the Association has been granted an exclusive license from the BCBSA to use the trademark BLUE SHIELD and the Blue Shield symbol in Canada.

The Association monitors not only its registered trademarks and authorized Common Law trademarks, but also any other forms of trademark display, such as within domain names, registered business names and other trade names.

Any deviation in use of a trademark from the form in which it is registered may jeopardize the validity of the registration and put all Licensees' use of such trademarks at risk.

To ensure that the Association's exclusive rights in these marks are not diminished, Licensees are not permitted to make any addition to, deletion from, or otherwise modify any trademark without the prior-written consent of the Association.

In addition, Licensees must not use the word BLUE, the color blue, the words CROSS or SHIELD, any representation of a cross and/or a shield in trade dress or as part of a trademark, tradename, domain name or sub-domain name, or in any other manner that could affect the integrity of the Marks, without the prior-written permission of the Association ([see Schedule C — Trademark, Tradename and Domain name Process](#)).
